I. COMPANY PROFILE:

II. JOB DESCRIPTION AND RESPONSIBILITIES:

The Managing Director is the Chief Executive of the Company and accountable to the Board of Directors / Government / Shareholders. He/She is responsible for the efficient functioning of the Company, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY:

1. QUALIFICATION:

Engineering Graduate / Chartered Accountant / Cost Accountant / Graduate with MBA or Post Graduate Diploma in Management (PGDIM) from a recognised University/Institute of repute.

2. AGE LIMIT:

Between 45 and 62 years as on the date of Notification

3. EXPERIENCE:

The applicant should possess minimum 15 years' experience in Engineering/ Production shop facilities of which at least 5 years on independent charge of the Company/ Head of the Department of company with an annual turnover of Rs. 90 crore or above. (The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised is considered). Should have experience in handling Finance/HR/Marketing.

4. SPECIAL NOTE:

(i) The period of appointment shall be 5 years or till attaining the age of 65 years whichever is earlier. In the case of those who are not completed 65 years of age, the period of extension will be considered on the basis of performance evaluation based on specific norms. (ii) The first one year of appointment shall be a probationary period. Service will not be extended if the performance as head of the institution during the probation period is not satisfactory. (iii) Deputation is not allowed for appointment to the post of Managing Director. (iv) For candidates from PSUs, No objection Certificate (NOC) from the head of the organization in which they are serving should be submitted along with the application.
