# I. COMPANY PROFILE:

In the year 2011, a Special Purpose Vehicle (SPV) for Varkala was formed by the Government for the comprehensive infrastructure and tourism development of Varkala and for enhancing tourism attractions in Varkala so as to increase the foreign and domestic tourist arrivals to many fold under the administrative control of Planning and Economic Affairs Department of Kerala. In 2012 the SPV was registered as a company under Companies Act (Act 1 of 1956) namely Vision Varkala Infrastructure Development Corporation Limited (VIVID Corporation).
